RE: Comments Regarding Proposed Changes to Fish Oil Monograph

To Whom It May Concern:

GOED, the Global Organization for EPA and DHA Omega-3s, represents the worldwide EPA and DHA omega-3 industry, with a mission to increase consumption of EPA and DHA omega-3s around the world. The membership is built on a quality standard unparalleled in the market and members must comply with quality and ethics guidelines that ensure members produce quality products that consumers can trust. Our 200+ members and partners represent the entire supply chain of EPA and DHA omega-3s, from fisheries and crude oil suppliers to refiners, concentrators and finished product brands.

GOED appreciates the opportunity to provide the Natural and Non-prescription Health Products Directorate (NNHPD) of Health Canada with comments on the proposed changes to the Fish Oil Monograph.

On 9 November 2023, GOED sent an email to Health Canada (nnhpd.consultation-dpsnso@hc-sc.gc.ca) seeking clarification on whether concentrated omega-3 oil from fish oil, referred to hereafter as 'concentrates,' remained within scope of the fish oil monograph and on 22 November, you confirmed that concentrates remained in scope and for clarification, you proposed further changes to the Fish Oil Monograph. A copy of the email exchange is attached for your reference.

Since GOED has members who have been granted product licenses for their concentrates based on the Fish Oil Monograph, it was good to receive confirmation that concentrates remain within scope. Given that the upper dosage ranges associated with the majority of the "Use(s) or Purpose(s)" would be unachievable without concentrates, it would not have made sense to exclude them.

As you know, concentrates with high levels of EPA and/or DHA can be produced from refined fish oils. These concentrates are in either ethyl ester or re-esterified triglyceride form and have always been considered to be within scope of the Fish Oil Monograph.

Unfortunately, your proposed further modifications inadvertently exclude concentrates. You proposed changing "This monograph only covers naturally occurring amounts of fatty acids in fish oil and would not cover fish oils that are concentrated or spiked" to "covers naturally occurring amounts of fatty acids." In order to ensure there is no question in the future about the inclusion of concentrates in the fish oil monograph, GOED proposes changing the text to *This monograph only covers naturally occurring amounts of fatty acids in triglyceride forms in fish oil and concentrated ethyl ester and re-esterified triglyceride forms from fish oil and would not cover fish oils that are*



spiked. We believe the changes are self-explanatory, but should you not agree, please let us know so we can provide an explanation.

GOED has one last comment and it relates to Table 2, footnote 2 – "Adult maximum dose is supported by EFSA 2012." While GOED agrees with referencing EFSA 2012, GOED recommends clarifying that the maximum daily dose is 5,000 mg EPA+DHA. In addition to EFSA 2012, we recommend referencing US FDA's 19 June 2019 letter of enforcement discretion in response to a health claim petition submitted by GOED. In the letter, the Agency refers to an updated safety review with the conclusion "..., we conclude that dietary supplements that provide no more than 5 g/day EPA and DHA when used as recommended or suggested in their labeling are safe..."

GOED appreciates your consideration of our comments.

Hi,

I work for GOED, the Global Organization for EPA and DHA Omega-3s, and we represent the worldwide EPA and DHA omega-3 industry. We plan to submit comments regarding the updated fish oil monograph, but I have a question that if you can answer would help me tailor our comments.

It appears that text may have been added to the fish oil monograph to exclude concentrated omega-3 oils from fish oil. If that was the purpose of the text, there is other added text that is contradictory.

The first text in question reads as follows, "This monograph only covers naturally occurring amounts of fatty acids in fish oil and would not cover fish oils that are concentrated or spiked." This contradicts information found as a footnote to Table 1, which reads, "Includes fish oil in its natural and/or triglyceride/triacylglycerol form and/or esterified form."

The reason the information is contradictory is that esterified forms of omega-3s from fish oil are considered concentrated.
If possible, it would be great if you can clarify the purpose of the text additions so that I can tailor GOED's comments and not have to address different scenarios (concentrates included versus excluded).
